Subject: Budget Amendment for 2022-23 Kings Basin Coordination Efforts

Dear Mr. Peters,

The Kings Basin Coordination efforts for the 2022-23 fiscal year are expected to total \$42,000 for the South Kings GSA. This is \$7,000 more than the projected \$35,000 budget for these tasks. The additional cost is primarily associated with increased efforts associated with the annual report, as well as additional coordination within the basin finalizing the revised GSPs and outlining the required data gap studies. Work under this effort will be completed in June 2023, and a new budget year for coordination efforts is initiated in July 2023. My understanding is that this work is covered under the SKGSA's annual budget. This task order is subject to the terms and conditions of the existing On-Call agreement with the South Kings GSA.

The budget for 2023-24 Kings Basin Coordination efforts is \$70,000 per GSA. The increased budget is anticipated for additional increased effort/requirements for the annual reporting, development of the coordinated well mitigation program, addressing GSP corrective actions required from DWR, and revisions to GSP related for 2025 updates.
